### Request for funding for the Rye Maritime Festival 2010

Dear Sir

The Rye Maritime Festival will be in its fifth year in 2010 and every year we try to make it bigger and better. Unfortunately, this does mean that it becomes harder to obtain funding for the event and we will be especially hard hit this year with the credit crunch. Last year we were saved by the intervention of the Environment Agency, without whose help the event would have to have been cancelled.

The Maritime Festival is organised by the Rye Harbour Sailing Club and the Rye Harbour Boat Owners Association and its aim is to promote Rye and Rye's maritime heritage as well as promoting leisure boating. Safety when afloat is also one of our aims and the Coast Guard and the RNLI who attend the festival assist us in this.

The festival takes place on Strand Quay (**the date this year is Sunday August 1st**) and is free to all visitors. We have boats of all types moored on the Strand dressed in all their finery, and the festival has encouraged visitors from other ports around the coast - last year we even had boats from French and Dutch ports attending, who had heard about the event from visitors from previous years. They had a great time, one boat staying in Rye for the remainder of the week.

All of this has unfortunately has to be paid for! Major items such as insurance, which seems to increase year by year, entertainment and first aid cover are huge outlays as well as there being many more minor costs. Therefore, we really need some help with funding and we would be very grateful if you would feel able to assist us this year with a grant as the festival helps to promote Rye, which is beneficial to everybody.
