7	For what purpose or project is the grant requested?	The grant is requested to provide music therapy sessions to members of the community who have special needs. This may be emotional, behavioural, autism, anxiety, learning and communication difficulties, ADHD, bereavement, trauma and stress. Music Therapy sessions also address problems for those with neurological problems due to strokes, Parkinsons Disease, accidents and so on as well as problems associated with aging. The sessions are one to one and build a therapeutic relationship through using easily played musical instruments. The music therapy service for the

		<p>people of Rye has been running since 2005, both at the Community Primary School and at a central location in Rye where adults may be seen. Ongoing feedback has been positive as to the usefulness of music therapy sessions and there is a waiting list of people wanting to access sessions. Due to Rye being an area of rural deprivation where many of the people who would benefit from music therapy are unable to afford it, we need to ask for funding support.</p> <p>This Grant would be specifically for the provision of music therapy sessions which are run by a Health Profession Council registered music therapist with clinical expertise and experience. We are hoping to expand the music therapy service into home visits for the elderly and housebound. We are also hoping to focus on providing sessions for carers and their very young children in order to promote attachment and wellbeing in family relationships. Another area The Music Well would like to address is supporting teenagers through musical activities in order to promote self confidence, motivation and social skills.</p>
8	What will be the total cost of the project?	£12800 (8 sessions per week through academic year of 40 weeks @ £40 per session. This covers the cost of the session, the administration, report writing, provision of instruments and use of room.)

9	If the total cost of the project is more than the grant requested, how will the remainder be financed?	<p>We have a grant from Jessies Fund of £4000 made in November 2010 with a further £2000 promised in November 2011. This will then be the end of their support.</p> <p>We also plan fundraising events during 2011. To</p>

		sustain the service we will be continuing our fundraising and applications into the future.
10	<p>Have you actually applied for a grant towards this project from other organisations? If so, which organisations, how much, and has funding been confirmed?</p>	<p>We have applied to Jessies Fund for support with the Music Therapy sessions. We have a grant of £4000 made in November 2010 and are promised £2000 in November 2011. This will be the end of their support.</p> <p>(Little Cheyne Wind Farm have granted £2500 towards the Drum circles and singing groups with £2500 to come after 6 months satisfactory results.</p> <p>The Rye Fund have granted £300 towards some drums. These are separate 'projects' for The Music Well)</p> <p>The Grant from Rye Town Council is specifically for the music therapy sessions which are a separate provision to the other musical activities run by The Music Well.</p>

12	<p>Who/What will benefit from this project and how?</p>	<p>Members of Rye and district community who have health needs ranging from Autistic spectrum Disorders to Stroke, mental health issues, learning disability, stress, problems due to age and infirmity will benefit.</p> <p>The music therapy sessions provide one to one therapy with a Health Professions Council registered music therapist who has clinical training. The sessions</p>

		<p>run from two centres in Rye, one of which is the Rye Community Primary School with wheelchair access. This enables children from outlying villages to access music therapy sessions as well as from The Childrens Centre and Rye College. ARRCC also send clients who need wheelchair accessible music therapy down to the school room.</p> <p>The other musical activities arranged by The Music Well will benefit members of the community in providing drums circles and singing, and home 'musical' visits to those who are housebound. These will be of benefit in mitigating isolation, depression, mental health and general wellbeing. It is hoped that these activities will also promote the wellbeing of the community in general and enhance communication between diverse elements of the community.</p> <p>At present the take up of music therapy sessions is comprised of around 70% Rye parish residents. The remaining percentage come from very nearby villages such as Camber and Rye Harbour, both very deprived areas.</p> <p>We feel that now Rye Town Council has the 'power of wellbeing' it is in a good position to support 'wellbeing through music', the chief aim of The Music Well.</p>





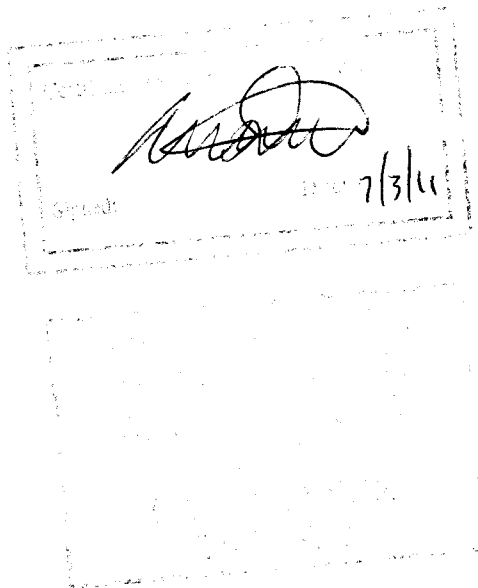
